LDP3 Evidence Gathering

South Ayrshire Council has launched a 'Call for Evidence' consultation as the first part of the Evidence Report stage in preparing the next Local Development Plan (LDP3).

The Council has decided to undertake the evidence gathering process in two stages with the first being a preliminary presentation of the evidence we have readily available. We are now seeking the views of those who live, work and visit South Ayrshire on the range and depth of the information that we already have, whether you think it's satisfactory, or whether you think additional information might be necessary.
